# CHANCE TO WIN A TRIP TO DISCOVER PUERTO RICO! CONTEST RULES

THE CHANCE TO WIN A TRIP TO DISCOVER PUERTO RICO! CONTEST (THE "CONTEST") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. PARTICIPANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "CONTEST RULES").

# 1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
  - (a) be a legal resident of the province of Ontario;
  - (b) be of the age of majority or older at the time of entry in the province of Ontario;
  - (c) reside within a one hundred fifty (150) kilometer radius of the city of Toronto, Ontario; and
  - (d) be legally able to travel from Toronto, Ontario to San Juan, Puerto Rico (the "**Destination**") and have any and all necessary documentation that may be required for presentation to Canadian and/or International customs and airport personnel.
- 1.2 The following people are not eligible to enter the Contest:
  - (a) Employees of Corus Radio Inc., operating as CFNY-FM (the "**Station**") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "**Corus**");
  - (b) Employees of Discover Puerto Rico, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "**DPR**", together with Corus, the "**Sponsors**");
  - (c) Employees of WestJet Airlines Ltd., its affiliates, subsidiaries, related companies, successors and assigns, advertising and promotional agencies (collectively "WestJet");
  - (d) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below; and
  - (e) The household members of any of the parties listed in Section (a) to (d) above.
- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.

2. CONTEST PERIOD. The Contest begins at 7:30 a.m. Eastern Time ("ET") on November 20, 2023 and ends at 8:00 a.m. ET on December 1, 2023 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

# 3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. To enter listen to the Station Monday through Friday during the Contest Period (excluding statutory holidays) at approximately 7:30 a.m. ET for the cue to text (the "Cue to Text") to be played. Upon hearing the Cue to Text, listeners are invited to text 416-870-3343 (the "Contest Line").
- 3.2 Limit of one (1) entry per household during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.3 All entries become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.4 Entries received by text message shall be deemed to be submitted by the authorized account holder of the cell phone number associated with the entry. For the purpose of the Contest Rules, "authorized account holder" of a cell phone number is defined as the natural person who is assigned to a cell phone account by a cellular service provider. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the cell phone number associated with their entry.
- 3.5 Streaming listeners may be listening to a delayed stream of the radio signal, which may vary depending on the device on which you are listening and the speed of the internet connection. Sponsors recommend turning on a radio to the Station for the Cue to Text. Sponsors assume no liability for entrants not making timely texts to the Station due to delays in the streamed signal.
- 3.6 If the telephone connection between the Station announcer and an entrant is not clear, such that the announcer and/or entrant cannot hear each other or the entrant is disconnected, that entrant may, in the sole discretion of the Sponsors, be disqualified and the Releasees (defined in Section 7 below) will not be liable in any way.

# 4. PRIZES.

- 4.1 There are a maximum of ten (10) qualifying prizes (each, a "Qualifying Prize", collectively the "Qualifying Prizes") available to be won by the Qualifying Prize winners (each, a "Qualifier", collectively the "Qualifiers") each of which consists of two (2) tickets to *Big Wreck* on December 22<sup>nd</sup>, 2023 at *History* in Toronto, Ontario. Each Qualifying prize has an approximate retail value of one hundred fifty Canadian dollars (CDN\$150.00).
- 4.2 There is one (1) grand prize (the "**Grand Prize**") available to be won by the Grand Prize winner ("**Grand Prize Winner**") consisting of a trip for two (2) to the Destination which shall include:
  - (a) round-trip economy airfare for the Grand Prize Winner and their guest (the "Guest") leaving together from the same gateway, on the same itinerary, from Pearson International

- Airport in Toronto, Ontario ("YYZ"), as determined by the Sponsors in their sole discretion, to Luis Muñoz Marín International Airport in San Juan, Puerto Rico ("SJU") on any WestJet marketed and operated flight (the "Flight");
- (b) ground transportation for the Grand Prize Winner and Guest between the airport and hotel at the Destination;
- (c) five (5) nights hotel accommodation at the Wyndham Grand Rio Mar hotel or other such venue to be selected by the Sponsors in their sole discretion for the Grand Prize Winner and Guest based on double occupancy unless otherwise indicated;
- (d) one (1) day pool cabana rental at the hotel;
- (e) one (1) round of golf for the Grand Prize Winner and Guest;
- (f) daily breakfast at the hotel for the Grand Prize Winner and Guest; and
- (g) a cheque for five hundred Canadian dollars (CDN \$500.00).
- 4.3 The Grand Prize has an approximate value of nine thousand eight hundred Canadian dollars (CDN \$9,800.00). Actual value of Grand Prize will depend on time of year of the booking.
- 4.4 Grand Prize and Qualifying Prizes are hereafter collectively referred to as "**Prize**" or "**Prizes**". Grand Prize Winner and Qualifiers are hereafter collectively referred to as a "**Winner**" or "**Winners**".
- 4.5 Winners are not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.6 The Sponsors and/or the Sponsors' representatives will contact each Winner to coordinate the provision of the Prize within two (2) days once such Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

# 5. PRIZE CONDITIONS.

- 5.1 All bookings and/or reservations are subject to availability at time of booking. Blackout dates apply, including but not limited to the following for the Flight: December 15-24, 2023, December 26-31, 2023, January 1-2, 2024, February 16-19, 2024, March 15-25, 2024 and March 28- April 1, 2024. Grand Prize Winner and their Guest must be available to participate in the Prize prior to December 1, 2024. Should Grand Prize Winner and/or Guest be unable to participate on the dates and times designated by the Sponsors, the Grand Prize will be forfeited and awarded to an alternate winner.
- 5.2 Winners and Guest will be responsible for any other expense not explicitly included in a Prize including but not limited to transportation to and from any Prize related location, transportation to and from originating airport, travel and medical insurance, travel documentation, airport improvement fees, bag check fees, taxes, surcharges, gratuities, telephone calls, concession fees, parking and in-room charges. Grand Prize Winner may be required to present a valid major credit card upon (i) time of flight booking to cover any fees, taxes and/or surcharges; or (ii) check-in at the hotel to cover any expenses over and above the standard room charge.

- 5.3 The Flight is valid on a regularly scheduled WestJet marketed and operated flight from YYZ to SJU and not applicable on connecting cities if winning origin is outside of Toronto, Ontario. The Flight does not include optional fees such as checked baggage or cabin upgrades. Please book early to maximize your flight options.
- 5.4 The Flight is limited and subject to promotional space availability of eligible fare options and flight schedule. Not all flights have promotional space. The Flight is not valid for redemption on *WestJet Vacations*' packages, flights operated by Swoop, interline, code share or charter flights.
- 5.5 The Flight cannot be extended. Additionally, changes to travel dates or guest names are not permitted once a booking has been confirmed The Flight becomes null and void if travel is cancelled once a booking is confirmed and all bookings and travel must be completed by the expiry date indicated on the Flight voucher.
- 5.6 Grand Prize Winner and Guest travelling on WestJet gift of flight voucher are not entitled to compensation amounts provided under passenger rights regimes. By redeeming this voucher, all guests travelling agree to release, and waive all claims against, WestJet relating to any and all liability, damage, or compensation entitlement arising under *Canada's Air Passenger Protection Regulations*.
- 5.7 WestJet and the other Releasees are not responsible for lost or mishandled vouchers. Once the Flight voucher has been delivered to the Grand Prize Winner, the Grand Prize Winner is directly responsible for it.
- 5.8 The Flight has a maximum potential retail value of two thousand three hundred eighty-eight Canadian dollars and ninety-six cents (CDN \$2,388.96), although the actual value will depend on the time of booking from originating city. Under no circumstance whatsoever will any difference between the actual and approximate retail values be awarded.
- 5.9 In the case of event tickets, gift cards or gift certificates, the terms by which the event tickets, gift cards or gift certificates may be redeemed are governed by the applicable retailer or service provider. Corus is not responsible for administering or ensuring compliance with the terms and conditions of the event tickets, gift cards or gift certificates.
- 5.10 In the event *Big Wreck* or any of its members are unable to attend the concert for any reason whatsoever or in the event that the concert is cancelled for any reason whatsoever, that portion of the Qualifying Prize shall be deemed fulfilled and will not be substituted, except in the sole discretion of the Sponsors.
- 5.11 Guest must: (i) be of the age of majority or older in their province or territory of residence; (ii) be legally able to travel to the Destination and have any and all necessary documentation as may be required for presentation to Canadian and/or International customs and airport personnel; and (iii) comply with the Contest Rules and sign and return the Release (described in Section 7 below).
- 5.12 Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of a Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.

5.13 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

### 6. WINNER SELECTION.

- 6.1 **Qualifier Selection.** Ten (10) Contestants (as defined below) shall be selected as follows:
  - (a) Approximately five (5) minutes after each Cue to Text is announced, one (1) entrant will be randomly selected from each Cue to Text pool of entrants and must answer the call from the Station (each a "Contestant") in order to be eligible to receive a Qualifying Prize and be entered into the draw for a chance to win the Grand Prize.
  - (b) If the Station is unable to reach the Contestant or the call back goes to voicemail (whichever comes first), another eligible entrant will be randomly selected.
  - (c) Each Contestant will be asked a question and if they answer correctly, they will receive a Qualifying Prize and be entered into the draw for the Grand Prize. If they answer incorrectly, they will be entered into the draw for the Grand Prize, but will not receive a Qualifying Prize.
  - (d) Each Contestant shall be eligible to win only one (1) Qualifying Prize per household during the Contest Period.
- 6.2 **Grand Prize Selection.** One (1) Grand Prize Winner shall be selected as follows:
  - (e) On or about December 1, 2023 in Toronto, Ontario, one (1) entrant will be selected by a random draw from all eligible entries received during the Contest Period.
  - (f) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE NO LATER THAN DECEMBER 4, 2023 AT 8:00 A.M. ET AND MUST RESPOND WITHIN TWO (2) BUSINESS DAYS OF NOTIFICATION.
- 6.3 The odds of being selected as a potential winner are dependent upon the number of eligible entries received by the Sponsors. Before being declared a Winner, the selected entrant shall be required to correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited, mathematical skill-testing question to be administered during a pre-arranged telephone call or by e-mail to comply with the Contest Rules and to sign and return the Release.
- 6.4 Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive a Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- 6.5 If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.

- 7. **RELEASE.** Potential Winners and Guest will be required to execute a legal agreement and release ("Release") that confirms potential Winners' and Guest: (i) eligibility for the Contest and compliance with these Contest Rules; (ii) acceptance of the Prize as offered; (iii) release of each of the Sponsors, WestJet and each of their employees, directors, officers, suppliers, agents, sponsors, administrators, licensees, representatives, advertising, media buying and promotional agencies (collectively, the "Releasees") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Contest, participation in any Contest-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation, or portrayal in a false light, or from any and all claims of third parties arising therefrom; and (iv) grant to the Sponsors of the unrestricted right, in the Sponsors' collective or individual discretion, to produce, reproduce, display, publish, convert, post, serve, broadcast, exhibit, distribute, adapt and otherwise use or re-use the Winner's and Guest's name, statements, image, likeness, voice and biography, in any and all media now known or hereafter devised, in connection with the Contest and the promotion and exploitation thereof. The executed Release must be returned within two (2) business days of the date indicated on the accompanying letter of notification or the verification as a Winner or the selected entrant will be disqualified and the Prize forfeited.
- 8. INDEMNIFICATION BY ENTRANT. By entering the Contest, each entrant releases, indemnifies and holds Releasees harmless from any and all liability for any injuries, loss or damage of any kind to the entrant or any other person, including personal injury, exposure to the COVID-19 virus, death, or property damage, resulting in whole or in part, directly or indirectly, from (a) their participation in the Contest or any Contest-related activity; (b) the acceptance, use, or misuse of any Prize; or (c) any breach of the Contest Rules. Each entrant agrees to fully indemnify the Releasees from any and all claims made by third parties relating to the entrant's participation in the Contest, without limitation.
- **9. LIMITATION OF LIABILITY.** The Sponsors assume no responsibility or liability for lost, late, unintelligible/illegible, falsified, damaged, misdirected or incomplete entries, notifications, responses, replies or any Release, or for any telephone, hardware or technical malfunctions that may occur, including but not limited to malfunctions that may affect the transmission or non-transmission of an entry. The Sponsors are not responsible for any incorrect or inaccurate information, whether caused by any of the equipment or programming associated with or utilized in the Contest or by any technical or human error which may occur in the administration of the Contest. The Sponsors assume no responsibility or liability in the event that the Contest cannot be conducted as planned for any reason, including reasons beyond the control of the Sponsors, such as tampering, unauthorized intervention, fraud, technical failures, or corruption of the administration, security, fairness, integrity or proper conduct of this Contest.
- 10. CONDUCT. By participating in the Contest, each entrant is deemed to have executed and agrees to be bound by the Contest Rules, which will be posted at <a href="https://edge.ca/contests/">https://edge.ca/contests/</a> throughout the Contest Period. Each entrant further agrees to be bound by the decisions of the Sponsors, which shall be final and binding in all respects. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant found to be: (a) violating the Contest Rules; (b) tampering or attempting to tamper with the entry process or the operation of the Contest; (c) violating the terms of service, conditions of use and/or general rules or guidelines of any Corus property or service; and/or (d) acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass the Sponsors or any other person. CAUTION: ANY ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. - 11.2 Each Winner further consents that: (a) any personal information they have provided in connection with this Contest may be shared with DPR, WestJet and/or the prize providers for the purpose of facilitating the delivery or fulfillment of a Prize; and (b) Corus may broadcast, publish, disseminate and otherwise use a Winner's name, city/town/village and province/territory of residence, image and/or voice in connection with any promotion and/or publicity purposes without further compensation to Winner.
- 11.3 No communication unrelated to the Contest, commercial or otherwise, will be sent to the entrant unless the entrant otherwise expressly agrees to receive further communications from Sponsors.

- 14. LAW. These are the official Contest Rules. The Contest is subject to applicable federal, provincial and municipal laws and regulations. The Contest Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over the Sponsors. All issues and questions concerning the construction, validity, interpretation and enforceability of the Contest Rules or the rights and obligations as between the entrant and the Sponsors in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
- **DISCREPANCY.** In the event of any discrepancy or inconsistency between the terms and conditions of the Contest Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, television, print or online advertising, the terms and conditions of the Contest Rules shall prevail, govern and control.
